RESOLUTION OF THE MANAGEMENT COMMITTEE

ANIMAL/PET RESOLUTION

This resolution is made this on the date set forth below by the Management Committee for Vivante Homeowners Association, Inc., a Utah non-profit corporation (the "Association").

RECITALS

WHEREAS, the Vivante Homeowners Association, Inc (the "Association") and the Unit Owners thereof, are required to comply with the requirements set forth in the Declaration of Condominium for Vivante ("Declaration") including all subsequent amendments and supplements thereto;

WHEREAS, the Management Committee is empowered to govern the affairs of the Association; including the interpretation and enforcement of the governing documents and the development and adoption of rules;

WHEREAS, the Declaration allows the Association to set forth rules and regulations concerning pets or animals within the Association;

WHEREAS, the Vivante Homeowners Association General Rules set forth requirements pertaining to those Unit Owners and occupants keeping pets;

WHEREAS, the Declaration, the Bylaws and the rules and regulations are binding upon all Owners, Occupants, their families, guests and invitees;

WHEREAS, for the health, safety, welfare, comfort and convenience of all residents, the Management Committee deems it in the best interests of the Association to herein ratify the previously adopted rules concerning pets and record this Resolution on all real property described in Exhibit A, which are subject to the terms of the Association's governing documents, to inform Owners and potential buyers of this established policy regarding pets;

NOW THEREFORE, IT IS RESOLVED AS FOLLOWS:

In harmony with the policy set forth in the rules and regulations, the pet rules are herein ratified, and the following is hereby adopted:

PETS

1. All dogs/cats must be on a leash when outside your Unit. No pet is to be left unattended outside, or tied to a door, bush or railing. **Only two (2) pets, and no pets over thirty (30) pounds, are allowed to reside or visit in the community.**

2. Due to exclusions in the Association's liability insurance coverage related to injuries within the Association from certain types of animals, the following breeds are prohibited and are subject to fines and demand for removal from the community:

Doberman Pincher
Rottweiler
Pit Bull Terriers
Chow Chow
Mastiff
German Shepherd
Great Dane

3. Consistent with West Valley City Ordinance(s), all pets must be licensed, and Owners are required to "clean up" after their pets.
4. Nuisance or noisy pets are not allowed and are subject to removal from the community. No breeding/raising of pets is allowed.
5. Rental Unit Owners should use discretion when allowing tenants to have pets. Pets are one of the main problems that the community has to deal with.

NOW THEREFORE, IT IS FURTHER RESOLVED:

Pursuant to the Declaration, any violation of the pet provisions of the Declaration, the Rules and Regulations of the Association, or this Resolution, may be subject to enforcement action which may include a fine, demand for permanent removal of the pet, legal action, or any other action or remedy authorized by the Declaration, this Resolution, or by law.

NOW THEREFORE, IT IS FURTHER RESOLVED:

The Pet Policy as it is established in the Rules and Regulations is binding and enforceable upon all Owners, Occupants, their families, guests and invitees. Fines or other enforcement action may be initiated for failure to comply with this Policy.

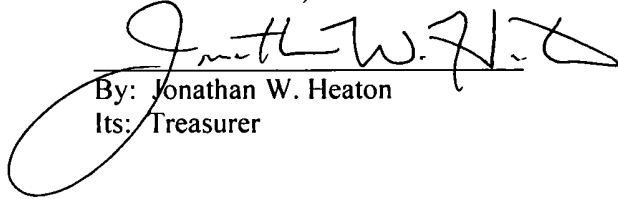
NOW THEREFORE, IT IS FURTHER RESOLVED:

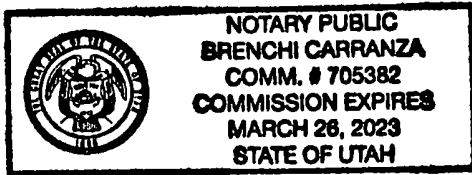
