<u>Dry Creek Structures, LLC</u>, a Limited Liability Company of the State of <u>Utah</u>, Grantor, hereby GRANTS AND CONVEYS to the UTAH DEPARTMENT OF TRANSPORTATION, at 4501 South 2700 West, Salt Lake City, Utah 84119, Grantee, for the sum of <u>(\$10.00) TEN Dollars</u>, and other good and valuable consideration, to wit:

A Perpetual Easement upon a parcel of land in fee, being part of an entire tract of land, situate in the Northeast quarter of section 23, and the Northwest quarter of the Northwest quarter of section 24 Township 5 South, Range 1 West, S.L.B. & M., in Utah County, State of Utah, for the purpose of constructing and maintaining thereon public utilities and appurtenant parts thereof including, but not limited to ATMS fiber optic conduit, electrical service and transmission lines, culinary and irrigation water facilities, and highway appurtenances including but not limited to slopes, street and signal lighting facilities, directional and traffic information signs, incident to the construction of a State Road known as Pioneer Crossing in Lehi Utah, also known as Project No. S-R399(42), and further described as follows:

Commencing at a point on the East corner of Section 23; thence North 00°30'42" West, along the section line a distance of 1,332.18 feet; thence West, a distance of 1,040.90 feet to the POINT OF BEGINNING; thence North 89°49'41" West, a distance of 10.00 feet; thence North 00°18'58" West, a distance of 14.50 feet; thence South 89°29'04" East, a distance of 10.00 feet; thence South 00°19'03" East, a distance of 14.44 feet to the POINT OF BEGINNING.

Containing 145 square feet or 0.0033 acres, more or less.

It is agreed hereby, that the Owners, by consent of the Utah Department of Transportation, shall have the right to lessen, but not to increase the vertical distance or grade of said cut and /or fill slopes, after said slopes are constructed on the above described lands at the expense of said Utah Department of Transportation, thereafter said Utah Department of Transportation is relieved of any further claim or demand for costs, damages, or maintenance charges which may accrue against said slopes and appurtenant parts thereof.
