SCOTT COOPER MCLACHLAN AND JULIE ANN MCLACHLAN, Grantors, hereby GRANT AND CONVEY to the CITY OF SARATOGA SPRINGS, Grantee, for the sum of ten dollars (\$ 10.00), and other good and valuable consideration, the following described right of way and temporary construction easement together with the right of ingress and egress over Grantor's adjacent lands for construction, use, operation, inspection, repair, maintenance, and replacement or removal of a sidewalk and related facilities in Utah County, State of Utah to-wit:

A parcel of land to be used for the widening of the Redwood Road right-of-way, to allow for the extension of the existing sidewalk at Dalmore Meadows Subdivision south to the northeast corner of the intersection of Redwood Road and Pioneer Crossing. Said parcel is located in the Northeast Quarter of Section 23, Township 5 South, Range 1 West, Salt Lake Base and Meridian, being more particularly described as follows:

Containing 684 square feet.

Together with a slope and temporary construction easement adjacent to the Redwood Road right-of-way to allow access during the construction of the sidewalk from the south end of the Dalmore Meadows Subdivision to the northeast corner of the intersection of Redwood Road and Pioneer Crossing, and to allow the placement of fill material as required to bring the sidewalk to the necessary grade to match the elevation of Redwood Road. The slope and temporary construction easement is twenty-feet-wide where parallel to Redwood Road, and ten-feet-wide in the diagonal portion of the right-of-way extending from Redwood Road southeast to Pioneer Crossing. Beginning at the northeast corner of the above described parcel, said point lies South 00°13'39" East long the Center of section line 866.34 feet and East 106.58 feet from the North Quarter Corner of Section 23, Township 5 South, Range 1 West, Salt Lake Base and Meridian (basis of bearing being South 00°13'39" East between the found North Quarter Corner and the found South Quarter Corner of said Section 23); and running thence East 20.00 feet; thence South 00°05'37" West 397.56 feet; thence South 43°02'49" East 108.76 feet; thence South 46°57'11" West 10.00 feet to the found right-of-way Marker 78 delineating the right-of-way of Pioneer Crossing and Redwood Road; thence North 43°02'49" West along said right-of-way from said Marker 78 to found right-of-way Marker 77 118.22 feet; thence North 01°04'52" East from said Marker 77 to found right-of-way Marker 25 18.34 feet; thence North 01°57'05" West along said right-of-way line 183.55 feet to the south corner of the above described parcel; thence North 00°05'37" East along the east line of said parcel 195.69 feet to the point of beginning.
