MAW, as trustees in trust, pursuant to a Trust Agreement executed between Grantor as Trustor and Grantees as Trustees on this 11th day of August, 1982, for the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the following described tracts of land in Weber County, State of Utah, to-wit:

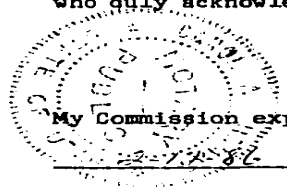
