of Utah County, State of Utah, do hereby convey and warrant to MOUNTAIN FUEL SUPPLY COMPANY, a corporation of the

State of Utah, Grantee, its successors and assigns, for the sum of One and -----
No 100 ----- Dollars: (\$1.00),

receipt of which is hereby acknowledged, a right of way and easement to lay, maintain, operate, repair, remove and replace pipe lines, gates and gate-boxes for transportation of gas through and across the following described land and

premises in Utah County, State of Utah, to-wit:

Part of North East 1/4 Section 6, T. 5 S., R. 1 E., S. L. B. & M.

Beginning at a point on the East Right of Way line of U. S. Highway #91, approximately 647.0' West and 415.0 ft. North of the Southeast corner of the North East 1/4 of Section 6, T. 5 S., R. 1 E., S. L. B. & M. Thence North 45.0 degree 00 Minutes East a distance of approximately 778.0 ft. to a point on the West line of County Road; said point being approximately 16.5 ft. West and 962 ft. North of the Southeast Corner of the Northeast 1/4 of Section 6, T. 5 S., R. 1 E., S. L. B. & M.

It is understood and agreed by and between the parties hereto that if said pipe line, herein described, is removed that Mountain Fuel Supply Company shall pay to Grantors the sum of Twenty Four Dollars.

The center line of which said gas pipe line shall extend through and across the above described land and premises on a line described as follows, to-wit:

TO HAVE AND TO HOLD the same unto the said MOUNTAIN FUEL SUPPLY COMPANY, its successors and assigns, so long as such pipe line or lines, gates or gate-boxes shall be maintained, with the right of ingress and egress to and from said right of way to maintain, operate, repair, remove and replace the same. The said Grantor's to fully use the said premises, except for the purposes for which this right of way and easement is granted to the said Grantee.

The said Grantor's for the consideration referred to above do hereby release and discharge the said Grantee, Mountain Fuel Supply Company, of and from any and all damages, claims, demands, actions or suits on account of damages to the above described land and premises sustained by the said Grantor's, their (His) successors, assigns or grantees, because of the construction, maintenance or operation of said pipe line.

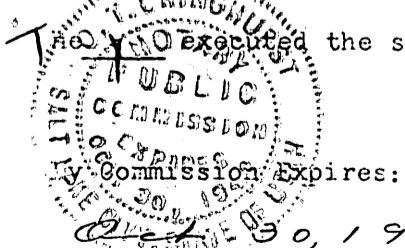

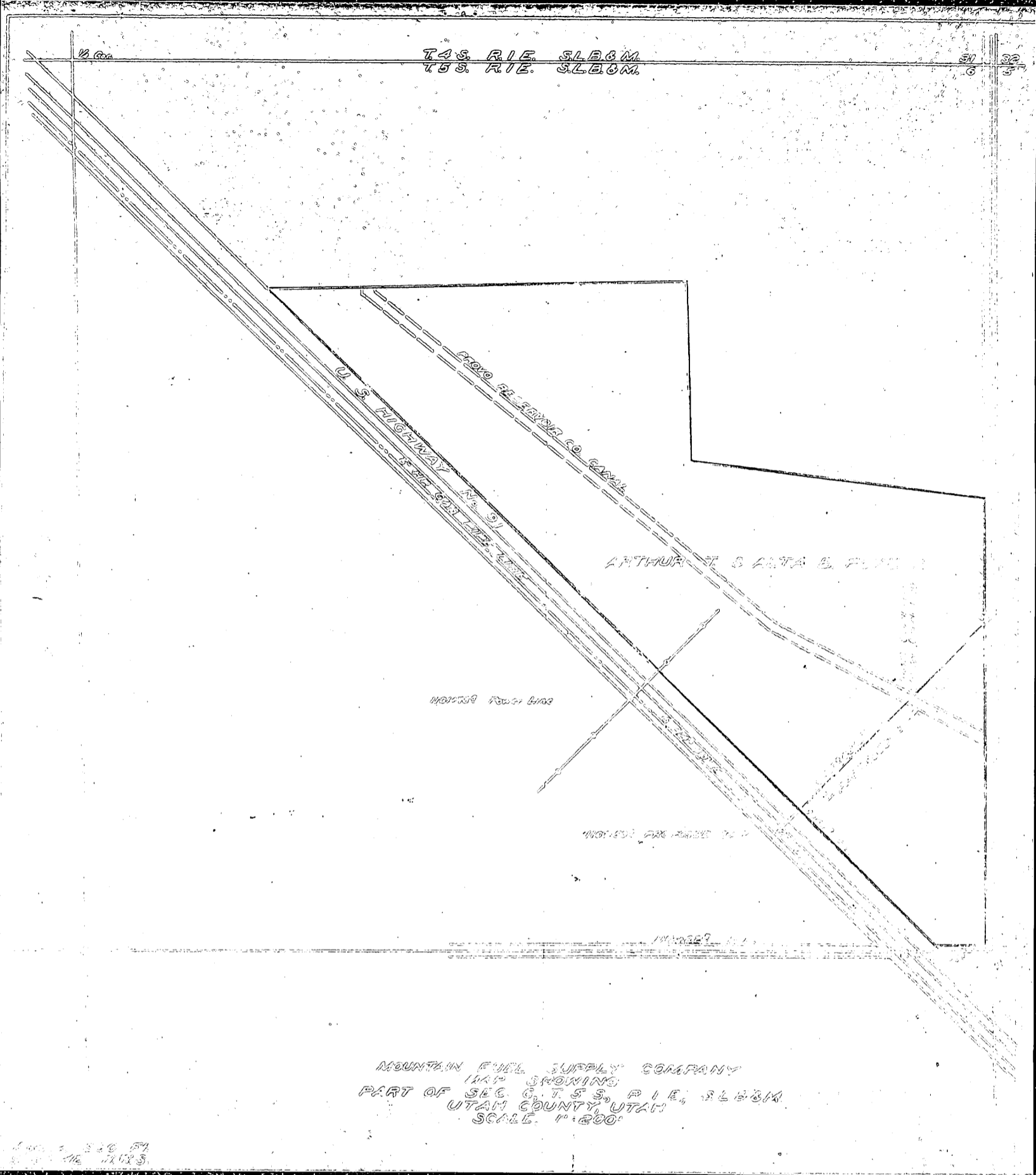
