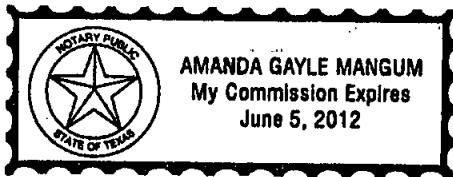

Beginning at a point on the North line of Glover Lane, said point being South 83°12'09" West 869.16 feet from the Center of Section 26, Township 3 North, Range 1 West, Salt Lake Base and Meridian, Davis County, Utah (basis of bearing is South 87°09'08" East between the witness corner to said center of section in the approximate center of 1525 West Street and the South witness corner to the East Quarter Corner of said Section 26) and running thence North 03°32'16" West 473.67 feet; thence South 89°23'30" East 142.87 feet; thence North 0°00'00" East 334.26 feet to a fence line; thence South 89°39'56" East 580.81 feet along said fence line to the West line of 1525 West Street; thence South 0°30'51" West 806.73 feet along said West line of 1525 West Street to the North line of Glover Lane; thence North 89°37'09" West 687.20 feet along said line to the point of beginning.
