LAND USE AGREEMENT

Be it known that the undersigned landowners, Graham Russell and Jodi Russell, acknowledge the Drinking Water Source Protection Plan for the Woodland Mutual Water Company well and agree to not locate, or allow the location of any potential contamination sources, as defined in R309-113-6(1)(u) within 100' feet of the well. It is further agreed by the landowners to not locate or allow the location of any pollution sources, as defined in R309-113-6(1)(t) of the Utah Administrative Code, within the following description of protection zone two unless design or operating standards are implemented to prevent contaminated discharges. This agreement is binding on all heirs, successors, and assigns.
