DEED OF EASEMENT

MAINE A. WHITESIDES and RUBY WHITESIDES, also known as Ruby B. Whitesides, husband and wife; JOHN V. ADAMS and DOROTHY E. ADAMS, husband and wife; ALICE M. SMITH, formerly Alice S. Whitesides, a married woman; of Layton, County of Davis, State of Utah; and STEWART C. WHITESIDES, Administrator of the Estate of Ferris C. Whitesides, County of Davis, State of Utah, hereinafter referred to as Grantor, hereby conveys to THE UNITED STATES OF AMERICA, acting pursuant to the provisions of the Act of June 17, 1902 (32 Stat., 388) and acts amendatory thereof or supplementary thereto, Grantee, for the sum of One Dollar (\$1.00), a perpetual easement to construct, reconstruct, operate and maintain an underground pipeline or pipelines and appurtenant structures which latter may protrude above the ground surface on, over or across the following described property in Davis County, State of Utah:

A tract of land in the Northwest Quarter of the Northwest Quarter (NW1/4NW1/4) of Section Ten (10), Township Four (4) North, Range One (1) West, Salt Lake Base and Meridian, being more particularly described as follows:

Beginning at the Northwest corner of said Section 10 and of the Grantor's property; and running thence East along the North line of the Grantor's property, Thirteen Hundred Fifty-nine and Eight-tenths (1359.8) feet, more or less, to the Northeast corner of the Grantor's property; thence South along the East line of the Grantor's property, Twenty (20.0) feet; thence West Five (5.0) feet; thence North 45°00' West Fourteen (14.0) feet; thence West Thirteen Hundred Forty-five (1345.0) feet to the West line of the Grantor's property; thence North Ten (10.0) feet to the point of beginning, containing 0.31 of an acre, more or less.
