WATER LINE EASEMENT

In consideration of the payment of \$1.00 in hand paid, receipt of which is hereby duly acknowledged, the undersigned, Maxwell W. Kirk and Nola G. Kirk, his wife, grantors, hereby grant and convey to Salt Lake County Recreation Board, grantee, a perpetual Easement over the property herein described for the purpose herein mentioned, namely the right to lay, maintain, operate, repair, re-lay and remove at any time a pipe line or pipe lines and appurtenant works for the conveyance of water with right of ingress to or egress from the same, on, over and through certain lands situated in the county of Salt Lake, State of Utah, and described as follows:

A strip of land fifteen (15) feet wide being seven and one-half (7 1/2) feet on each side of the following centerline.

Beginning at a point on the North line of the Grantor's' property, which point lies South 79.65 feet and West 256.23 feet from the Northeast corner of Section 2, T 2 S, R 1 W, of the SLB & M, and running thence S. 6°10' E. 161.2 feet more or less to the South line of the Grantor's property, insofar as said easement lies within the Grantor's property.
