# WARRANTY DEED

of Salt Lake City, Salt Lake County, Utah grantee for the sum of Ten (\$10.00) and other good, valuable, and sufficient consideration. DOLLARS, the following described tract of land in situ in Little Cottonwood Mining ~~County, State of Utah~~ District, Salt Lake County, State of Utah, to wit:
