AN ORDINANCE

AMENDING AN ORDINANCE passed by the Board of Commissioners of Salt Lake City on April 16, 1957, Bill No. 14, vacating portions of 2nd South Street between 3rd and 4th East Streets and 3rd East Street between 1st and 2nd South Streets, adjacent to Block 50, Plat "B", Salt Lake City Survey.

Be it ordained by the Board of Commissioners of Salt Lake City, Utah,

SECTION 1. That the ordinance passed April 16, 1957, Bill No. 14, vacating certain portions of 2nd South Street between 3rd and 4th East Streets and 3rd East Street between 1st and 2nd South Streets, adjacent to Block 50, Plat "B", Salt Lake City Survey be amended to read as follows:

Beginning at the southwest corner of Lot 2, Block 50, Plat "B", Salt Lake City Survey; thence east 660.8 feet, to the southeast corner of Lot 1, of said Block 50; thence south 5.9 feet; thence west 660.8 feet; thence north 5.9 feet to the point of beginning.

Also: Beginning at the southwest corner of Lot 2, Block 50, Plat "B", Salt Lake City Survey; thence west 6.0 feet; thence north 660.0 feet; thence east 6.0 feet to the northwest corner of Lot 5, of said Block 50; thence south 660.0 feet to the point of beginning.

Also: Beginning at the southwest corner of Lot 2, Block 50, Plat "B", Salt Lake City Survey; and running thence west 6 feet; thence south 5.9 feet; thence east 6 feet; and thence north 5.9 feet to the point of beginning.

That the above described tracts of land are hereby vacated and declared no longer to be public property for use as a street, avenue, alley or pedestrian way. Said vacation is made expressly subject to all existing rights of way and easements of all public utilities of any and every description now located in, on, under or over the confines of the above described property; and also subject to the rights of entry thereon for the purpose of inspecting, maintaining, repairing, replacing, removing, altering or relocating said utilities and all of them.

SECTION 2. In the opinion of the Board of Commissioners, it is necessary to the peace, health and safety of the inhabitants of Salt Lake City that this ordinance shall become effective immediately.

SECTION 3. This ordinance shall take effect upon its first publication.
