PART OF THE NORTHEAST QUARTER OF SECTION 5, TOWNSHIP 6 NORTH, RANGE 1 WEST, SALT LAKE MERIDIAN, U.S. SURVEY: BEGINNING ON THE WEST LINE OF THE STATE ROAD NORTH 1969.8 FEET AND NORTH74D30' EAST 1705 FEET AND NORTH 87D16' EAST 410.5 FEET AND SOUTH ALONG ROAD 226.5 FEET OF THE SOUTHWEST CORNER OF SAID QUARTER SECTION; THENCE SOUTH 89D16' WEST 109.5 FEET; THENCE SOUTH 50' WEST 103.5 FEET; THENCE NORTH 89D16' EAST 109.5 FEET TO ROAD; THENCE NORTH ALONG ROAD TO BEGINNING.

To Whom it May Concern,

The parcel of land with the Land Serial Number 11-014-0016 is currently zoned Agricultural (A-1) which requires a minimum lot size of 40,000 square feet and a minimum lot width of 150 feet on a dedicated right of way. This parcel was created prior to the enactment of zoning regulations and is considered a legal-nonconforming parcel as it now stands. The parcel currently contains approximately .26 acres and has 103.5 feet of frontage.

The Weber County Planning Commission would issue a Land Use Permit for a home to be rebuilt on this parcel as the parcel now stands, provided that the parcel boundaries are not altered in any manner unless through an approved subdivision process, and that the new home meets the required setbacks for the zone in which it lies at the time the home is rebuilt. There may be additional requirements that need to be met before a building permit will be issued.
