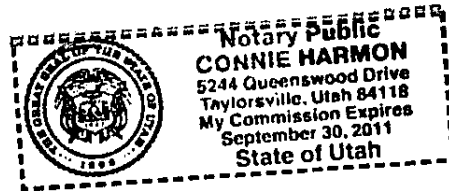

AP-23: Fee Parcel 15-03-101-025-0000

A parcel of land in fee, being part of an entire tract of property, situate in the SW¼SW¼ of Section 34, Township 1 North, Range 1 West, Salt Lake Base and Meridian incident to the construction of the "Airport Light Rail Transit Project", a Utah Transit Authority project, known as "ALRT", and described as follows:

Beginning at the Northwest corner of said entire tract and the southerly right of way line of North Temple Street, which point is 325.91 feet N.89°57'15"E. along the section line and 672.63 feet North from the Southwest corner of said Section 34; thence N.89°58'38"E. 15.50 feet along said southerly right of way line and the northerly boundary line of said entire tract; thence S.00°11'08"E. 7.81 feet along an easterly boundary line of said tract; thence S.89°57'15"W. 15.50 feet to the westerly boundary line of said entire tract; thence N.00°11'08"W. 7.81 feet along said westerly boundary line to the point of beginning.

The above described part of an entire tract contains 121 square feet in area or 0.003 acres.
