a perpetual easement, upon part of an entire tract of property, in the SW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 34, T.1N., R.1W., SLB&M, in Salt Lake County, Utah, for the purpose of constructing thereon a traffic signal pole and appurtenant parts thereof.

The boundaries of said part of an entire tract are described as follows:

Beginning at a point in the Southerly right of way line of North Temple Street 66.60 feet perpendicularly distant southerly from the monument line of said Street, at a point opposite Engineers Station 100+39.00, which point is also 504.03 feet N. 89°12'01" E. and 700.45 feet North and 25.15 feet S. 89°58'38" W. from the Southwest corner of said Section 34; thence S. 0°01'22" E. 6.00 feet; thence S. 89°58'38" W. 8.00 feet; thence N. 0°01'22" W. 6.00 feet to said southerly right of way line; thence N. 89°58'38" E. 8.00 feet along said right of way line to the point of beginning as shown on the official map of said project on file in the Office of the Utah Department of Transportation.
