ASSIGNMENT AND QUIT CLAIM AND CONVEYANCE

THIS ASSIGNMENT AND QUIT CLAIM AND CONVEYANCE (hereinafter the "Conveyance") is made this 27th day of September, 2012, by WHISPER RIDGE DEVELOPMENT, LLC, a Utah limited liability company acting for the purpose of winding up its affairs (hereinafter "Whisper Ridge") to and for the benefit of BANK OF AMERICAN FORK (hereinafter "Grantee").

RECITALS:

A. Whisper Ridge is the Declarant under that certain Declaration of Covenants, Conditions and Restrictions for Whisper Ridge at Stone Canyon dated June 24, 2008 and recorded in the office of the County Recorder of Morgan County, State of Utah on June 25, 2008, as Entry No. 112595, in Book 265, at Pages 862, et seq. (as amended, the "Declaration").

B. The Declaration affects and encumbers that certain real property located in Morgan County, State of Utah and more particularly described in Exhibit A attached hereto and by this reference made a part hereof (hereinafter the "Project Property").

C. Pursuant to the Declaration, the Declarant has the right to expand the Project to include certain "Additional Land" (as defined in the Declaration). The Additional Land is more particularly described on Exhibit B attached hereto and by this reference made a part hereof.

D. Grantee has acquired fee title to those portions of the Project that are more particularly described on Exhibit C attached hereto and by this reference made a part hereof (hereinafter the "Bank of American Fork Project Property") and has also acquired fee title to those portions of the Additional Land that are more particularly described on Exhibit D attached hereto and by this reference made a part hereof (hereinafter the "Bank of American Fork Additional Land").

E. Pursuant to this Conveyance, Whisper Ridge intends to assign, quit claim and convey to Grantee all of Whisper Ridge's right, title and interest as Declarant under the Declaration.

NOW, THEREFORE, for One Thousand Dollars (\$1,000.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the parties to this Conveyance, Whisper Ridge does hereby assign, quit claim and convey to Grantee all of Whisper Ridge's right, title and interest as Declarant under the Declaration. This Conveyance is made without representation or warranty of any kind for the sole purpose of conveying Whisper Ridge's right, title and interest as Declarant under the Declaration to Grantee.
