**BOUNDARY LINE AGREEMENT**

KNOW ALL MEN BY THESE PRESENTS:

1. The undersigned hereby agree that the following described line is and shall constitute the boundary line between the property of ELMER M. HOGGE and BETTY F. HOGGE, Trustees of the ELMER M. and BETTY F. HOGGE FAMILY REVOCABLE TRUST dated February 9, 1998 on the Northeast and KAYSVILLE CITY, a municipal corporation on the Southwest.

**BOUNDARY LINE:**

A part of the Southwest Quarter of Section 36, Township 4 North, Range 1 West, Salt Lake Base and Meridian, Fruit Heights, Utah, being along a fence line and described as follows:

Beginning at the Easterly most Northeast Corner of the Kaysville City Property, said point being on the south line of the Elmer M. and Betty F. Hogge Family Revocable Trust dated February 9, 1998, North 89°59'50" East 1005.73 feet along the section line and North 414.46 feet from the Southwest Corner of Section 36, Township 4 North, Range 1 West, Salt Lake Base and Meridian, and running;

Thence South 71°15'00" West 53.80 feet along the south line to the Southwest Corner of the Elmer M. and Betty F. Hogge Family Revocable Trust dated February 9, 1998;

Thence North 33°30'00" West 261.00 feet along the west line to the Northwest Corner of the Elmer M. and Betty F. Hogge Family Revocable Trust dated February 9, 1998, being the end.
