construction, use, occupation, or enjoyment of the said temporary detention basin easement

and the installation, operation, maintenance and repair of facilities therein. Said temporary

easement shall permit the stockpiling and specify the placement of dirt excavated during

The Grantee shall be solely responsible for the site and the installation, maintenance

and repair of all storm drain facilities placed on the site. Upon termination of this temporary

left on the site shall become the property of Grantor without payment of any compensation

to Grantee. Grantee shall give Grantor not less than ninety (90) days written notice of intent

to remove any facilities from the site.

Grantee agrees to indemnify and hold Grantor harmless for any claim, loss or

damage, including attorneys' fees and court costs, against Grantor in any way arising out of

or in any way connected with this grant of temporary easement and Grantee's use of the site.

This temporary easement shall remain in full force and effect until an alternate means

of conveying and detaining storm water for the area has been constructed and put into

service, or until December 31, 2020, whichever occurs first.
