Grantors, hereby grant to Snyderville Basin Sewer Improvement  
District, of Summit County, State of Utah, an easement for  
the construction and maintenance of a sewer line on and across  
the following property located in Summit County, State of Utah:

A sewer line easement 20 feet wide, 10 feet on either  
side of the following described centerline: Beginning  
at a point on the east line of grantors' property on a  
line common to the Charles Maedel property, said point  
being S 18°17' E 196 feet more or less from the NW  
corner of said Charles Maedel property, said point also  
being North 4099.44 feet, more or less, and West 800.43  
feet, more or less, from the SE corner of Section 10,  
Township 1 South, Range 3 East, Salt Lake Base & Meridian;  
thence S 60°44'07" W 170.30 feet; S 65°34'18" W 219.53  
feet; S 67°08'34" W 8.0 feet, more or less, to a fence  
marking the boundary of grantors' property; thence N  
66°07'43" E 8.0 feet; S 14°30'33" E 100 feet. Together  
with a temporary construction easement 30 feet wide,  
15 feet on either side of said centerline.

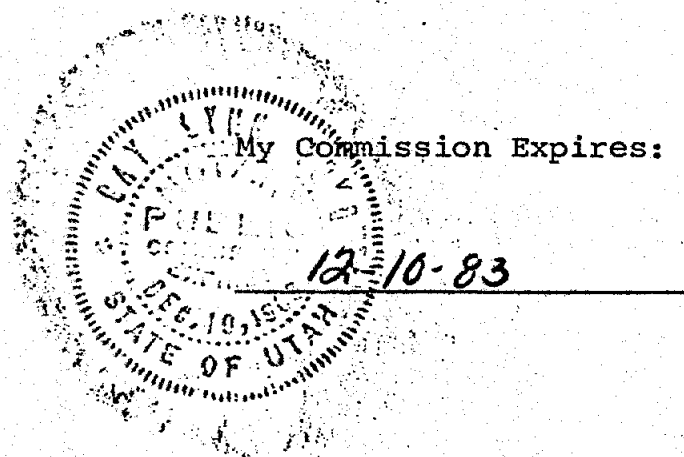
