

Also, beginning at the north boundary line of the Grantors' land at a point one foot east, from the northwest corner of Section 26, T. 6 S., R. 2 W., S.L.M., thence S. 0° 07' E. 2698.2 feet on said land and being in the W 1/2 of the NW 1/4 and the NW 1/4 of the SW 1/4 of said Section 26.
One guy anchor located on the Grantors' land at a point 31 feet north and 31 feet west, more or less, from the southeast corner of Section 15, T. 6 S., R. 2 W., S.L.M., and being in the SE 1/4 of the SE 1/4 of said Section 15.
