AN ORDINANCE

AN ORDINANCE VACATING Floral Street between 2nd and 3rd South Streets in Salt Lake City, Utah.

Be it ordained by the Board of Commissioners of Salt Lake City,

SECTION 1. That, Floral Street between 2nd and 3rd South Streets in Salt Lake City, Utah, more particularly described as follows:

Beginning at a point 77 ft. west from the southeast corner of Lot 3 Block 50, Plan "A," Salt Lake City Survey, there thence 100 ft. thence west 2 ft. thence north 100 ft. thence west 9 ft. thence north 84 ft. thence east 7 ft. thence north 98 ft. thence west 15 ft. thence north 43 ft. thence west 10 ft. thence north 186 ft. thence west 18 ft. thence south 130 ft. thence east 2 ft. thence south 200 ft. thence east 2 ft. thence south 142 ft. thence east 3 ft. thence south 188 ft. thence west 10 ft. to the place of beginning.

be and the same is hereby vacated and declared no longer to be public property for use as a street, avenue, or any pedestrian way.

Said vacated street made expressly subject to all existing rights of way and easements of all kinds still in or of any and every description now located on, in, under or over the confines of the above described property and also subject to the right of entry thereto for the purpose of inspecting, maintaining, repairing, replacing, removing, altering, routing said utilities and all of them.

SECTION 2. In the opinion of the Board of Commissioners, it is necessary to the health and safety of the inhabitants of Salt Lake City that this ordinance shall become effective immediately.

SECTION 3. This ordinance shall take effect upon its first publication, and is passed by the Board of Commissioners of Salt Lake City, Utah, this 29th day of April, A.D., 1948.
