EASEMENT

1. Eldon D. Pugh, dba Eldon Pugh Machine and Intermountain Farmers Association, a corporation doing business in the State of Utah, Grantor, hereby conveys to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection, operation and continued maintenance, repair, alteration, inspection, relocation and replacement of the electric transmission and distribution circuits of the Grantee, with the necessary poles, towers, guys, stubs, crossarms, braces and other attachments affixed thereto, for the support of said circuits, on, over and across a tract of land located in Salt Lake County, Utah, along the following described center line:

Beginning on the west boundary line of the Grantor's land at a point 182 feet north, more or less, from the southwest corner of Lot 4, Block 46, Plat "A", Salt Lake City Survey, thence N. 81° 43' E. 267 feet, more or less, on said land and being in Lots 3 and 4 of said Block 46.
