AMENDED NOTICE OF ADOPTION OF REDEVELOPMENT PLAN ENTITLED
"DEPOT DISTRICT REDEVELOPMENT PROJECT AREA PLAN" AND DATED
OCTOBER 15, 1998

Pursuant to Section 17A-2-1257, Utah Code
Annotated, 1953, as amended, the following information is
recorded in the Office of the Recorder of Salt Lake
County:

(1) Previous Notice Recorded: On October 22, 1998,
as Entry No. 7127194, Book 8133, Pages 1835 and 1836, the
Redevelopment Agency of Salt Lake City recorded a Notice
of Adoption of Redevelopment Plan Entitled "Depot District
Redevelopment Project Area Plan" and dated October 15,
1998.

(2) Notice Recorded in Error: On April 22, 1999,
as Entry No. 7329735, Book 8270, Pages 3839 and 3840, the
Agency recorded a "Notice of Adoption of Redevelopment
Plan entitled Granary District Redevelopment Project Area
Plan and dated April 15, 1999" which erroneously contained
the legal description of the Depot District Redevelopment
Project Area rather than the Granary District Project
Area. The Depot District Project Area and the Granary
District Project Area are separate and distinct project
areas. The Agency desires to reaffirm that the previous
Notice recorded on October 22, 1998 is correct by
recording this Amended Notice.

(3) A Description of the Land Within the Project
Area.

This Amended Notice is to reaffirm that the land
located within the Depot District Project Area is
described as follows:

Beginning at the Southwest Corner of the
Intersection of 400 South Street and 400 West Street, Salt
Lake City, Utah; thence North along the West right of way
line of 400 West Street to the Northwest Corner of the
Intersection of North Temple Street and 400 West Street;
thence West along the North right of way line of North
Temple Street to a point where the North right of way line
of North Temple Street intersects with the East right of
way line of the Interstate Highway I-15; thence

Southwesterly along an irregular course following the East right of way line of Interstate Highway I-15 to a point where the East right of way line of Interstate Highway I-15 intersects with the South right of way line of 400 South Street; thence East along the South right of way line of 400 South Street to the point of beginning.

Included within the Project Area are all of Blocks 46, 47, 62, 63, 64, 65, 80, 81, 82 and 83 of Plat "A", Salt Lake City Survey; all of Blocks 35, 36, 37, 48 and 49 of Plat "C", Salt Lake City Survey; and part of Blocks 38, 47, 50 and 60 of Plat "C", Salt Lake City Survey as shown in the official records.

(4) A Statement that the Redevelopment Plan for the Project Area has been Approved. The City Council of Salt Lake City adopted the Redevelopment Plan entitled "Depot District Redevelopment Project Area Plan" dated October 15, 1998 by Ordinance No. 76 of 1998 dated October 15, 1998.


