# NOTICE OF REINVESTMENT FEE COVENANT

(Edgewood Estates)

Pursuant to Utah Code Ann. § 57-1-46(6), the Edgewood Estates Homeowners Association, Inc. ("Association") hereby provides this Notice of Reinvestment Fee Covenant which burdens all of the real property described in <a href="Exhibit A">Exhibit A</a> (the "Burdened Property"), attached hereto, which is subject to the Second Amended and Restated Declaration of Covenants, Conditions, and Restrictions of Edgewood Estates recorded with the Davis County Recorder on November 4, 2019 as Entry No. E 3200923 B 7382 P 445-491, and any amendments or supplements thereto (the "Declaration").

The Reinvestment Fee Covenant requires, among other things, that upon the transfer of any of the Burdened Property subject to the Declaration, the transferee, other than the Declarant, is required to pay a reinvestment fee as established by the Association's Board of Directors in accordance with Section 5.19 of the Declaration, unless the transfer falls within an exclusion listed in Utah Code § 57-1-46(8).
