LOW-INCOME HOUSING CREDIT COMMITMENT AGREEMENT

AND DECLARATION OF RESTRICTIVE COVENANTS

This Amendment to Low-Income Housing Credit Commitment Agreement and Declaration of Restrictive Covenants (the "Amendment") is made effective as of the 23 day of December, 2019, by and between NORTHWEST SANDSTONE, LLC, an Idaho limited limitity company, its successors and assigns (the "Project Owner"), and UTAH HOUSING CORPORATION, a public corporation of the State of Utah ("Utah Housing").

RECITALS

WHEREAS, the Project Owner and Utah Housing entered into and executed that certain Low-Income Housing Credit Commitment Agreement and Declaration of Restrictive Covenants, effective as of September 26, 2019 (the "Original Agreement"), which was recorded in the Iron County real property records on October 4, 2019, as Entry No. 734534, in Book 1459, at Pages 1773-1786, which provided for certain regulatory and restrictive covenants governing the use, occupancy and transfer of that certain low-income housing tax credit project known as The Sandstone (the "Project").

WHEREAS, following the execution and recording of the Original Agreement the legal description of the property on which the Project is located was adjusted;

WHEREAS, the Project Owner and Stah Housing have agreed to amend the Original Agreement in order to reflect the updated legal description for the Project.

NOW THEREFORE, in consideration of the mutual promises set forth above, and based upon the mutual covenants and promises hereinafter set forth, and such other valuable consideration the receipt and sufficiency of which is hereby acknowledged, the Project Owner and Utah Housing agree to amend and restate, in its entirety, the legal description in Exhibit A of the Original Agreement to read as follows:
