The undersigned, having been duly sworn, hereby deposes and says as follows:

- I am a resident of Salt Lake County, State of Utah, over the age of twenty-one years and in all respects competent to testify to the matters contained herein.
- 2. I am a Licensed Escrow Officer of Cottonwood Title Insurance Agency, Inc. which maintains its principal place of business at 1996 East 6400 South, Suite 120, in Salt Lake City, County of Salt Lake, State of Utah.
- 3. That on April 23, 2021 Cottonwood Title Insurance Agency, Inc. contracted with Notarize.com for a Special Warranty Deed and a Temporary Utility Easement to be signed with Tyler Ritchie Bingham.
- 4. That the aforementioned Special Warranty Deed, now on record with the Weber County Recorder as of April 26, 2021 as Entry No. 3141720 _____, was signed through Notarize.com on the same day, and with the same notary, as the aforementioned Temporary Utility Easement.
- 5. That the referenced date on which the grantor signed the document of April 22, 2021 was incorrect, and the grantor did, in fact, sign the document on April 23, 2021.
- 6. That the notary acknowledgment referenced within the Temporary Utility Easement contained a typographical error wherein the county reference was not legible. The county in which the notary was acknowledged should read "Montgomery," which is the same county referenced in the notary acknowledgment in the aforementioned Special Warranty Deed.
- 7. That the notary acknowledgment referenced within the Temporary Utility Easement contained a typographical error wherein the date referenced was not legible, and the date on which the notary was acknowledged should read "April 23, 2021," which is the same date referenced in the notary acknowledgment in the aforementioned Special Warranty Deed.
- 8. The above statements apply to the following described easement estate:


