EASEWENT

Chief Engineer's Deed No.5971

THIS INDENTURE, Made this 21st day of February, A.D. 1917, between Mary L.Morris, a widow of Salt Lake City, Utah, grantor, and the Oregon Short Line Railroad Company, a corporation of the State of Utah, grantee,

WITNESSETH, That the said grantor,———————————————————————————for the sum of One and No/100 (\$1.00) Dollars, hereby grants and conveys unto the said grantee, and to its successors and assigns, a perpetual easement for the sole and exclusive use for a right of way for its proposed spur track in and to the following described land, in Salt Lake City, Salt Lake County, Utah, to-wit:

A strip of land seventeen (17) feet wide, being eight and five tenths (8.5) feet on each side of the center line of said proposed spur track as the same is now located over and across the South sixty-five (65) feet of Lot Eight (8), Block Sixty-two (62), Plat "A", Salt Lake City Survey, the location of said center line of spur track being more particularly described as follows:
