# ABSTRACT OF FINDINGS AND ORDER

I, Verene A. Froisland, being first duly sworn, depose and say that I am the Secretary to the Salt Lake City Planning Commission (451 South State Street, Room 406), and that on Thursday, January 21, 1999, Case No. 410-334 by John Williams was heard by the Salt Lake City Planning Commission. The applicant requested a conditional use for a waiver of the 40% glass requirement at 414 West 300 South in a Downtown "D-3" zoning district. The actual building site is viewable only from 400 West at approximately 250 South.
