11501 RIGHT OF WAY AGREEMENT

FOR

Wendell T. Moyle and Lucille W. Moyle
his wife, of Alpine, Utah Co, State of Utah, Grantors, do hereby
convey and warrant to the City of Alpine

Utah County, Utah, organized and existing under and by virtue
of the laws of the State of Utah, Grantee, a right of way and easement for the purpose
of digging a trench along said right of way, and to lay, maintain, operate, repair,
remove or replace main pipe line for transportation through and across the Grantors'
land and premises in Utah County, State of Utah

The right of way and easement herein granted is located in:
NE 1/4 Sec. 19, T. 4 S., R 2 E SLB&M
Utah County, State of Utah

the center line of said main pipe shall extend through and across the above land
and premises on a line described approximately as follows: Begin at a point on the
grantors North property line, said point being 1372.0 ft. West of the NE Cor. Sec. 19,
T. 4 S., R. 2 E. SLB&M.; thence S. 1° 30' W. 571.6 ft.; thence N. 89° 50' W. 357.4
ft.; thence S. 8° 30' W. 599.6 ft. to the grantor South property boundary.
During initial construction said easement shall not exceed 16.5 feet each side of the
center line.

TO HAVE AND TO HOLD the same unto the City of Alpine
so long as such main pipe line shall be maintained, with the right of ingress and
egress to and from said right of way, and to maintain, operate, repair and remove
or replace the same. The said Grantors to have the right to fully use the said
premises for purposes not in conflict with the purposes for which this right of way
or easement is granted to the said Grantee.

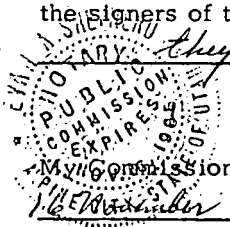
The rights hereby granted are subject to the condition that Grantee shall
compensate Grantor at a reasonable appraised valuation for any damages done to
Grantors' land or crops caused by Grantee in the construction, maintenance, repair
and operation or replacement of said main pipe line.
