KNOW ALL MEN BY THESE PRESENTS; That Iron County, a municipal corporation of the State of Utah, grantor, for and in consideration of twenty-five Dollars in hand paid to it by the grantee herein does hereby grant, convey, release and quit claim unto AMERICAN TELEPHONE AND TELEGRAPH COMPANY OF WYOMING, its successors and assigns, grantee, the right, privilege and authority to construct, reconstruct, operate and maintain a line of telephone and telegraph consisting of such poles wires, cables, conduits, guys, anchors and other fixtures and appurtenances as the grantee may from time to time require upon, across, over and/or under the property which it owns or in which it has any interest in the County of Iron, State of Utah, within the following described property to-wit;

The grantor, for itself and its successors and assigns, hereby covenant that it will not voluntarily permit of <sup>any</sup> such a wire line to be erected or permitted on said property of such a nature or at such a distance as to interfere with the service of the grantee, or endanger its line, and further covenants, for itself and its successors and assigns that it will not voluntarily permit any inflammable structure to be erected on said property at a distance so close to the line of the grantee as to endanger the same.

The grantor for itself and its successors and assigns, hereby covenants that it will not voluntarily permit any wire/ lines to be erected or permitted on said property of such a nature or at such a distance as to interfere with the service of the grantee or endanger its line, and further covenants, for itself and its successors and assigns that it will not voluntarily permit any inflammable structure to be erected on said property at such a distance so close to the line of the grantee or to endanger the same.

BE IT FURTHER RESOLVED that the Chairman of the Board of County Commissioners and the clerk thereof BE AND THEY ARE HEREBY AUTHORIZED to execute a grant embodying the terms of this resolution, "
