any piece or parcel of land, situate in the County of Morgan State aforesaid,

from (14), of Section Twenty (20), in Township Two (2) North, Range Two (2) East, of the Salt
Lot 10 (10), Two (2), Three (3), Northeast Quarter (NE4) of the Northeast Quarter (NE4),
Quarter (NE4) of the Northwest Quarter (NW2) of Section Eighteen (18), in Township Two (2) North,
(3) East, of the Salt Lake Meridian.
