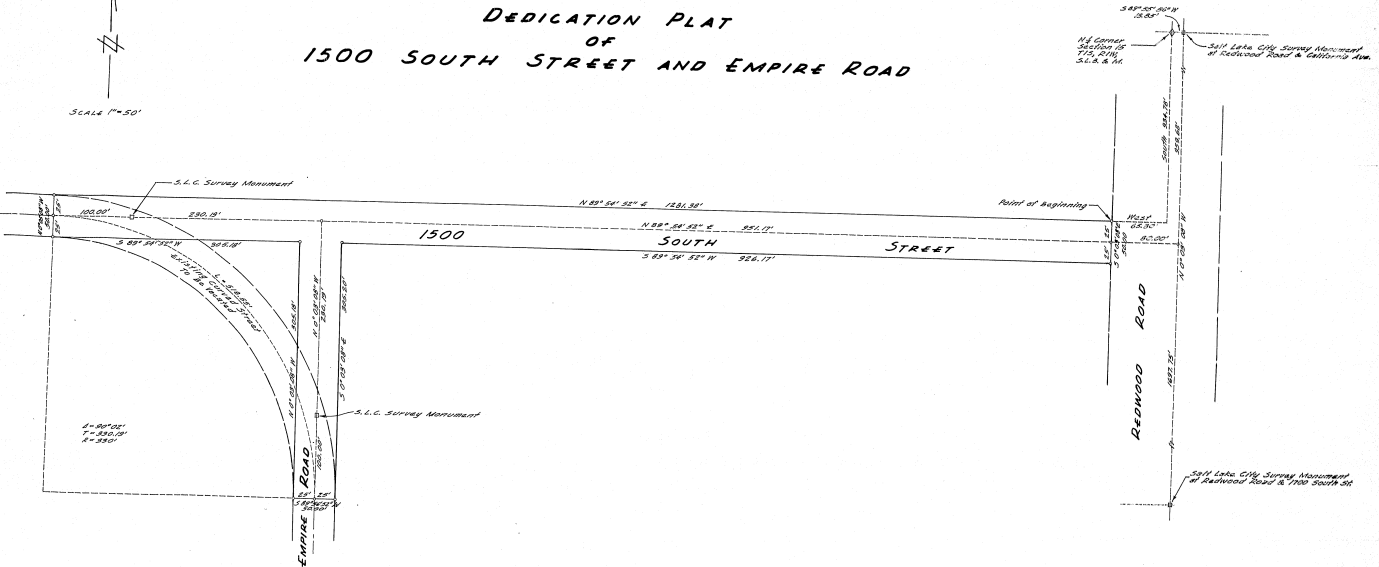


DEDICATION PLAT OF 1500 SOUTH STREET AND EMPIRE ROAD
