DEED AND CONVEYANCE

KNOW ALL MEN BY THESE PRESENTS:

THAT, WHEREAS, the undersigned PARK UTAH CONSOLIDATED MINES COMPANY, a corporation organized and existing under the laws of the State of Delaware (hereinafter sometimes called the verantor), and the Directors thereof, and SILVER KING COALITION MINES COMPANY, a corporation organized and existing under the laws of the State of Nevada (hereinafter sometimes called Silver King), and the Directors thereof, heretofore on, to-wit, the 3rd day of March, 1953, made and entered into an Agreement of Consolidation providing that the Grantor be consolidated with Silver King to form a new corporation to be organized and to exist under the laws of the State of Delaware and to be named UNITED PARK CITY MINES COMPANY (hereinafter sometimes called the Grantee), under and pursuant to Sections 251 and 252 of the General Corporation Law of Delaware and Section 39 of the Domestic Corporation Law of Nevada; and
