

A right of way ten feet in width, being five feet on each side of the following described centerline:



Baginning on the east boundary line of the Grantor's land being the west right of way line of Industrial Road, at a point 2223 feet north and 1575 feet west, more or less, from the south one quarter corner of Section 15, T. 18., R. 1W., S.L.M., thence West 25 feet, more or less, on said land, and being in the NW 1/4 of the SW 1/4 of said Section 15.
