AMENDED ORDINANCE #86-60

AN ORDINANCE AMENDING THE OFFICIAL STREET MAP OF SANDY CITY ESTABLISHING THE ALIGNMENT OF 255 WEST STREET SOUTH OF 9000 SOUTH AND ESTABLISHING A FUTURE RIGHT OF WAY ALIGNMENT WHICH EXTENDS MONROE STREET (150 WEST) SOUTH OF APPROXIMATELY 9300 SOUTH AND THEN ALONG A SOUTHWEST DIAGONAL INTERSECTING WITH 255 WEST AT APPROXIMATELY 9600 SOUTH AND REQUIRING DEDICATION OR RESERVATION OF A RIGHT OF WAY ALONG SALD ALLIGNMENTS

BE IT KNOWN AND REMEMBERED that the City Council of Sandy, State of Utah finds and determines as follows:

WHEREAS, amendments to the official street map have been proposed; and

WHEREAS, the Planning Commission of Sandy City has held a public hearing to consider said proposals; and

WHEREAS, the City Council has held a public hearing to consider said proposals; and

WHEREAS, the establishment of an alignment for the extension of 255 West Street south of 9000 South is in the best interests of the City; and

WHEREAS, the establishment of a future right of way alignment which extends Monroe Street (150 West) south of approximately 9300 South and then along a southwest diagonal intersecting with 255 West Street at approximately 9600 south and requiring dedication or reservation of a public street right-of-way at such location is in the best interests of the City.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Sandy, State of Utah, that 255 West shall be extended south of 9000 South Street along the alignment shown on Exhibit A which is attached hereto and by this reference made a part hereof; and

BE IT FURTHER ORDAINED that a future right of way alignment, which extends Monroe Street (150 West) south of approximately 9300 South and then along a southwest diagonal intersecting with 255 West Street at approximately 9600 intersecting with 255 West Street at approximately 9600 South, is established which alignment is shown on Exhibit A and that dedication of said rights of way is required. As an alternative to dedication, the City may accept conveyance of a public street right-of-way, in form acceptable to the City Attorney, provided (1) a minimum 15-foot landscaping City Attorney, provided (1) a minimum 15-foot landscaping from the current canal right-of-way; and (2) fencing meeting from the current canal right-of-way; and (2) fencing meeting City requirements is provided along the canal right of way.

Section 2. All former ordinances or parts thereof conflicting or inconsistent with the provisions of this ordinance hereby adopted are hereby repealed.

Section 3. The provisions of this ordinance shall be severable; and if any provision thereof, or the application of such provision under any circumstances is held invalid, it shall not affect any other provision of this ordinance, or the application in a different circumstance.

This ordinance shall become effective upon Section 4. its publication as required by law.
