AN ORDINANCE OF THE DRAPER CITY RENAMING GAEEN A PAREFUTY - WI 3 P. BOULEVARD TO VISTA STATION BOULEVARD FROM 12300 SOUTH TO APPROXIMATELY 13400 SOUTH

**WHEREAS,** Title 10-8-32 of the Utah Code authorizes municipalities change the names of streets; and

**WHEREAS,** Draper City has received requests from the property owner along Galena Park Boulevard to rename the street to Vista Station Boulevard from 12300 South to approximately 13400 South; and

WHEREAS, the Draper City Council finds that good cause exists for the change in the name and neither the public interest nor any person will be materially injured; and

WHEREAS, letter and notice was given to all property owners, residents and businesses along the affected area and their concerns were heard.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF DRAPER CITY, STATE OF UTAH, AS FOLLOWS:

<u>Section 1.</u> Street Name Change. Galena Park Boulevard is hereby renamed to Vista Station Boulevard from 12300 South to approximately 13400 South as shown on the attached map which by this reference is made a part hereof.

<u>Section 2.</u> Additional Language. Vista Station Boulevard shall also include the language "550 West" and include an additional sign with the name "Historic Galena Park Boulevard".

<u>Section 3</u> **Effective Date.** This Ordinance shall become effective immediately upon its passage.


