EASEMENT 119-78-E

Neil C. Stauffer & Mrs. Neil C. Stauffer, his wife Grantors  
of Salt Lake City, County of Salt Lake, State of Utah hereby  
license and permit the State Road Commission of Utah, and Cahoon-Maxfield  
Irrigation Company, Licensees, for the sum of Forty four and 00/100  
Dollars to use the following described premises situated upon the grantors land in  
Lot 2 of Section 18, T. 2 S., R. 1 E., S. L. M.

in Salt Lake County, Utah, for the purpose of reconstructing and maintaining  
thereon an irrigation ditch and appurtenant parts thereof:

A parcel of land 10 ft. wide adjoining westerly the westerly right of way line  
of state highway known as Project No. U-119, from Engineer's Station 257+57.5 to 258+53,  
the boundaries of said parcel being described as follows:

Beginning at the intersection of the southerly boundary line of said grantors  
land and said westerly right of way line at a point 52.5 ft. perpendicularly distant  
westerly from the center line of survey of said project; said point being also approx-  
imately 656 ft. east and approximately 450 ft. north along said westerly right of way  
line from the W<sup>1</sup> corner of said Section 18; thence westerly 10 ft. along said southerly  
boundary line; thence N.2°15'E., 95.5 ft., more or less, to the northerly boundary line  
of said grantors land; thence easterly 10 ft., more or less, along said northerly boundary  
line to said westerly right of way line; thence southerly 95.5 ft., more or less, along  
said westerly right of way line to the point of beginning. Above described parcel of  
land contains 0.022 acre, more or less.

After said irrigation ditch is reconstructed on above described premises  
at the expense of the Road Commission, the Cahoon-Maxfield Irrigation Company is  
thereafter granted the right to maintain and operate said irrigation ditch on the  
above described premises, and the Road Commission is thereafter relieved of any  
further claim or demand for costs, damages or maintenance charges which may accrue  
against said irrigation ditch or appurtenant parts thereof.
