QUIT-CLAIM DEED

CAHOON and MAXFIELD IRRIGATION COMPANY, a Utah non-profit mutual water corporation, GRANTOR, for ten dollars (\$10.00), and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, hereby quit claims to MURRAY CITY CORPORATION, a municipality of the State of Utah, GRANTEE, all of its right, title and interest, however acquired, in and to that certain water conveyance facility and its diversion structures and other appurtenant facilities, all commonly known as the Cahoon and Maxfield Irrigation Company Canal and Ditch System, ("Canal and Ditch System"), which is located in Salt Lake County, State of Utah. The approximate location of the Canal and Ditch System is shown on the attached Exhibit "A", which is incorporated herein by this reference.

This conveyance shall also include all of GRANTOR'S right, title and interest, however acquired, in and to all easements, licenses and rights of way on property under or adjacent to the Canal and Ditch System to GRANTEE, including, but not limited to, all access rights of way, maintenance easements, permissive easements and licenses previously obtained or used for the construction, operation, maintenance, repair and replacement of the Canal and Ditch System. The approximate locations of the access rights of way, maintenance easements, permissive easements and licenses are shown on attached Exhibit "A", which is incorporated herein by this reference.

This conveyance shall also include the right of GRANTEE to transport water through the Canal and Ditch System, and to operate, maintain, repair and replace the Canal and Ditch System.
