

This resolution and explanation according to the terms of the said act, shall not be construed to include coal and iron lands; so that and to hold the said lands with the appurtenances into the said Union Pacific Railway Company, and to the same extent with the resolution and explanation as before. On testimony thereof, I Charles D. Arthur, President of the United States, have caused this letter to be made a part and the rest of the General Land Office to be known as follows. Given under my hand at the City of Washington, this sixteenth day of February, in the year of our Lord one thousand eight hundred and eighty four, and of the independence of the United States the one hundred and eighth.

The United States of America, do all to whom these presents shall come, greeting:

Whereas, by the acts of Congress approved July 1, 1862, as amended by the act of July 2, 1864, and in the construction of railroad and telegraph lines from the summit of the Pacific Ocean to some of the Government of the same for postal, military and other purposes; and thereby so given to the Union Pacific Company a contract a railroad and telegraph line under certain conditions and stipulations as expressed in said acts; provision is made for granting to the said company, every of certain portion of public lands designated by said acts, and the amount of the same to be determined by the terms of the said resolution, on the line thereof, and within the limits of the lands on said acts of said act, not only several, or otherwise occupied by the United States, and to which a reservation or some other claim may not have attached at the time the line of road was originally given.

And whereas an official statement bearing date November 3rd 1869, and revised by the signature of the Secretary of the Interior has been filed in the General Land Office, showing that the Government, approved by the President, under provisions of the said act of Congress approved July 1, 1862, and the next section of the said act of Congress approved July 2, 1864.

have reported to him that a portion of the line of railroad and telegraph from Omaha in the State of Nebraska, Westward to Ogden in the Territory of Utah and known as the Union Pacific Railroad has been constructed and fully completed and equipped in the manner prescribed by the Act of Congress relative to the Pacific Railroad and Telegraph line; and the said Union Pacific Railroad Company, has applied for a conveyance of the title to the lands granted to said Company by the said Act of Congress of July 1, 1862 and July 2, 1864:

And Whereas, certain tracts have been stipulated, under the Act aforesaid, by Ascer F. Davis, the Agent for the said Union Pacific Railroad Company as shown by his original list of selections dated August 19, 1876, certified under date of August 31, 1876, by the Register and Receiver at Salt Lake City, Utah Territory. The said tracts being described as follows, to wit:

North of base line and West of Salt Lake Principal Meridian.

Township One, Range One.

East half of the North East quarter, South West quarter, and West half of the South East quarter of Section One, containing Three hundred and twenty acres.

East half of Section three, containing Three hundred and nineteen acres and forty hundredths of an acre.

South half of the North West quarter, North half of the South West quarter and North half of the South East quarter of section five, containing two hundred and forty acres.

North East quarter of the North East quarter and the East half of the South East quarter of section seven, containing one hundred and twenty acres. West half of the South West quarter of section nine, containing eighty acres.

East half of the South East quarter of section seventeen, containing eighty acres. East half of the South East quarter of section twenty one, containing eighty acres. North West quarter of the North East quarter, South half of the North East quarter, North half of the North West quarter, South East quarter of the North West quarter, North half of the South East quarter and South East quarter of the South East quarter of section twenty seven, containing three hundred and sixty acres. Now Know Ye, the United States of America, in consideration of the premises and pursuant to the said acts of Congress, Have Given and Granted, and by these presents Do give and Grant unto the Union Pacific Railroad Company and to its assigns, the tracts of lands selected as aforesaid and described in the foregoing: (Yet excluding and excepting from the transfer by these presents, "All mineral lands", should any such be found to exist in the tracts described in the foregoing; but this exclusion and exception according to the terms of the statute, shall not be construed to include "Coal and Iron Lands"*)

To Have and to Hold, the said tracts with the appurtenances unto the said Union Pacific Railroad Company and to its assigns forever, with the exclusion and exception as aforesaid.

In Testimony Whereof, I, Ulysses S. Grant President of the United States, have caused these letters to be made patent, and the seal of the General Land Office to be hereunto affixed.
