DEED OF CONVEYANCEWITHGRANTS OF EASEMENTS

COLUMBIA STEEL COMPANY, a corporation organized and existing under

and by virtue of the laws of the State of Delaware, Grantor, hereby grants and conveys unto GENEVA STEEL COMPANY, a corporation organized and existing under and by virtue of the laws of the State of Delaware, Grantee, those certain parcels of land situate, lying, and being in the County of Utah, State of Utah, and particularly described as follows, to wit:
