GRANTS OF SECURITY

PROPERTY MORTGAGED. All such costs and expenses incurred by Lender together with interest thereon calculated at the Default Rate shall be deemed to constitute a portion of the Debt and be secured by this Trust Deed and the other Loan Documents and shall be immediately due and payable upon demand by Lenger therefor.

ACTIONS AND PROCEEDINGS.
