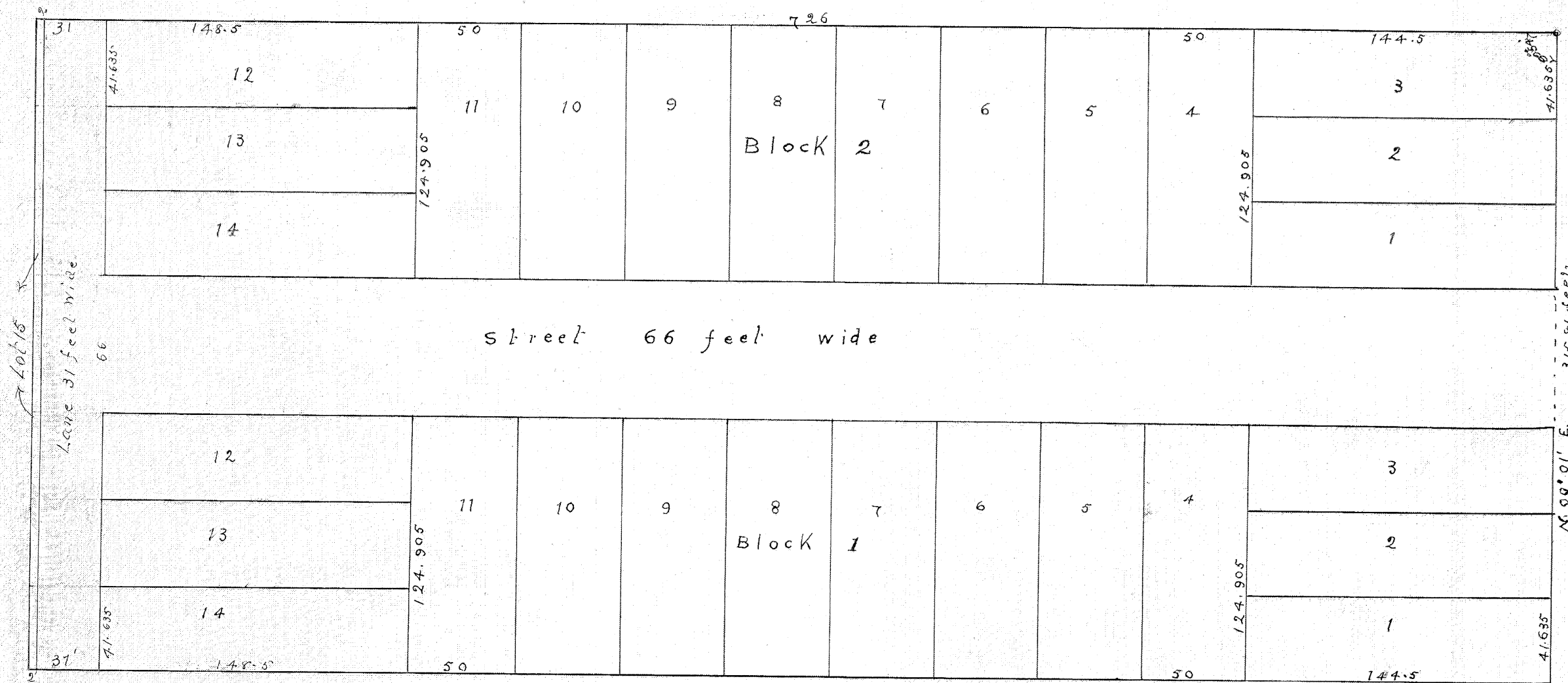

SURVEYOR'S CERTIFICATE.

I hereby certify that the tract of land shown on this map and owned by John M. Macfarlane and Nora Macfarlane his wife, and Louis W. Harris and Jessie S. Harris his wife, is bounded and described as follows to-wit: beginning at the northeast corner of Lot sixteen, Block thirty three (33) Ten acre plat A. Big Field survey; thence running south nineteen and $\frac{1}{10}$ (19.14) rods. Thence west forty four (44) rods. Thence north nineteen and $\frac{1}{10}$ (19.14) rods. Thence east forty four (44) rods to the place of beginning, containing five and $\frac{25}{1000}$ (5.025) acres, and known as the northern part of Lot sixteen, Block thirty three (33) Ten acre plat A. Big Field survey; that I have, by authority of the said owners thereof subdivided the same into lots and street, to be known as CENTRAL SUBDIVISION; that the same has been correctly staked out on the ground as represented hereon, and that the steel tape used in making the survey thereof was of correct length.

NAMES AND DIMENSIONS OF PARCELS OF LAND DESIGNATED FOR PUBLIC USE:

Streets.
One lane thirty one feet wide and three hundred and fifteen and $\frac{1}{10}$ feet long north and south.
One street sixty six feet wide and six hundred and ninety three feet long running east and west.

DIMENSIONS OF LOTS.

Lots one to three inclusive in Blocks one and two are forty one and $\frac{5}{1000}$ feet by one hundred and forty four and five tenths feet.
Lots four to eleven inclusive in blocks one and two are fifty feet by one hundred and twenty four and $\frac{1}{1000}$ feet. Lots twelve to fourteen inclusive in blocks one and two are forty one and $\frac{5}{1000}$ feet by one hundred and eighty one and five tenths feet. Lot 15 is 200 feet by 100 feet and is to become part of street when street is opened to its full width, namely sixty six feet.
This map is accurately drawn to a scale of fifty feet to one inch.
