MERRELL, Grantors for TEN DOLLARS (\$10.00) and other valuable consideration, receipt of which is hereby acknowledged, hereby sells, grants and conveys to UINTAH SCHOOL DISTRICT, Grantee, an easement and right of way for a road across the following described tract of land situated in Uintah County, Utah, to-wit:

A 30' Road and Utility Easement in the SE½ of Section 21, Township 4 South, Range 21 East, Salt Lake Base and Meridian described as follows: Beginning on the North-South ½ section line of said Section, S 1 degree 46'54" E - 874.51' from the Center of said Section; thence N 88 degrees 32'35" E - 30'; thence S 1 degree 46'54" E 610.5'; thence S 88 degrees 32'35" W - 30' to the said N-S ½ Section Line; thence N 1 degree 46'54" W along said line - 610.5' to point of beginning. Contains 0.17 acres more or less. Basis of bearings is the Official Map of Vernal City dated 1966.

Grantee shall have the right to enter upon the above-described land and grade, level, fill, drain, pave, build, maintain, repair and rebuild a road or street together with such bridges, culverts, ramps and cuts as may be necessary on, over and across said property.
