**NOTICE OF HOMEOWNERS ASSOCIATION AND REINVESTMENT FEE

Duration: The duration of the reinvestment fee is perpetual.


Purpose: The purpose of the reinvestment fee is to cover association expenses, including without limitation: administrative expenses; purchase, ownership, leasing construction, operation, use, administration, maintenance, improvement, repair, or replacements of association facilities, including expenses for taxes, insurance, operating reserves, capital reserves, and emergency funds; common planning, facilities, infrastructure expenses; obligations arising from an environmental covenant; community programming ; resort facilities; open space; recreation amenities; or charitable expenses.

Reinvestment Fee Amount: The reinvestment fee is 1/2 % of the sales price of the home.

ALL REQUESTS FOR ASSOCIATION INFORMATION, INCLUDING PAY-OFF DUE FOR SELLER, IS TO BE REQUESTED VIA E-MAIL 24 HOURS IN ADVANCE OF DATE NEEDED OR A \$100 RUSH FEE WILL BE APPLIED TO THE REINVESTMENT FEE. WHEN SENDING REQUEST, INCLUDE ADDRESS, LOT NUMBER, SELLER NAME AND ESTIMATED DATE OF CLOSING. IF A FORECLOSURE SALE, INCLUDE BANK NAME AND DATE OF FORECLOSURE.


