VACATING A PORTION OF 100 NORTH STREET, KAYSVILLE CITY, DAVIS COUNTY, STATE OF UTAH; PROVIDING FOR THE RECORDING OF SUCH ORDINANCE AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the governing body of Kaysville City, State of Utah, has determined that there is good cause for vacating the portion of 100 North Street at about 650 East, an areas of approximately .014 acres; and

WHEREAS, the City has caused to be published a "Notice of Proposal To Vacate a Portion of 100 North Street and Public Hearing Theron," for the purpose of calling a Public Hearing to consider the question of whether or not the portion of said street should be vacated; and

WHEREAS, said Public Hearing was held at the Kaysville Municipal Center on Thursday February 7, 2019; and

WHEREAS, after due deliberation by the Mayor and City Council, it is now found and determined that good cause exists for vacating said portion of 100 North Street and that neither the public interest nor any person will be materially injured by the vacation and that it is in the best interest of the City and its inhabitants to vacate said portion of said Street;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF KAYSVILLE CITY, UTAH:

# SECTION 1: PORTION OF 100 NORTH STREET VACATED

The portion of 100 North Street at about 650 East, an area of approximately 0.37 acres and the same is hereby vacated as a public street, which said portion of said street is more particularly described as follows;

BEGINNING AT THE NORTHEAST CORNER OF LOT 2, CURZON PLACE PHASE 2 SUBDIVISION, SAID POINT BEING SOUTH 89°33'30" EAST 268.44 FEET ALONG THE SOUTH LINE OF 100 NORTH STREET FROM THE NORTHWEST CORNER OF BLOCK 12, PLAT "E", KAYSVILLE TOWNSITE SURVEY, SAID POINT ALSO BEING SOUTH 46°20'35" WEST 1118.03 FEET (CALCULATED BEARING AND DISTANCE) FROM THE CENTER QUARTER CORNER OF SECTION 35, TOWNSHIP 4 NORTH, RANGE 1 WEST, SALT LAKE BASE AND MERIDIAN, RUNNING THENCE NORTH 17°33'23" EAST 5.76 FEET TO A POINT ON A 45.00-FOOT-RADIUS CURVE TO THE LEFT; THENCE NORTHERLY 68.98 FEET ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 87°50'03", CHORD BEARS NORTH 13°44'23" WEST 62.43 FEET TO THE NORTH LINE OF 100 NORTH STREET; THENCE SOUTH 89°33'30" EAST 48.11 FEET ALONG SAID NORTH LINE; THENCE NORTH 66°10'00" EAST 198.60 FEET ALONG SAID NORTH
