DECLARATION OF INTENT CONCERNING CONSENT TO SURFACE ENTRY

KNOW ALL MEN BY THESE PRESENTS:

THAT T. E. JEREMY, also known as THOMAS E. JEREMY, and REBECCA D. JEREMY, his wife, of Salt Lake City, Utah and GRACE J. CASSADAY of Long Beach, California, (hereinafter collectively referred to as "GRANTORS") executed and delivered certain Special Warranty Deeds on the 13th day of January, 1967 transferring the real property described therein located in the County of Salt Lake, State of Utah which Special Warranty Deeds and the real property conveyed thereby are more particularly described in Exhibit "A" attached hereto and by this reference made a part hereof.

THAT the Special Warranty Deeds referred to in Exhibit "A" attached hereto transferred and conveyed that certain real property therein described subject to the following reservation, condition and covenant:

An undivided one-half (1/2) interest in and to any and all present rights of Grantors to oil and gas and other minerals in and under said real property subject to the condition that any exploration for or development of oil and gas or other minerals insofar as the rights of Grantors and Grantees are concerned, shall require prior written consent and approval of Grantees.

THAT it is the desire of GRANTORS to clarify the meaning of the right to consent to surface entry for exploration for or development of oil and gas and other minerals on the hereinbefore described real property which right to consent is set forth in the reservation, condition and covenant contained in the Special Warranty Deeds described in Exhibit "A" attached hereto and in the immediately preceeding paragraph.

NOW THEREFORE, it is hereby declared to have been on the date

of conveyance and is now the express intent of the GRANTORS that the right to consent to surface entry for exploration for or development of oil, gas and other minerals in and under the hereinbefore described real property as set forth in the Special Warranty Deeds referred to in Exhibit "A" is a restriction, condition and covenant that runs with the land and is binding upon the GRANTORS and the Grantees under the Special Warranty Deeds referred to in Exhibit "A" and their heirs, successors, assigns, transferees and grantees taking by, or through or under them.
