A G R E E M E N T

An agreement entered into this 17th day of May, 1966 between Spring Creek Irrigation Company, hereafter referred to as COMPANY; Cottonwood Mall Shopping Center, Inc., hereafter referred to as MALL; and Salt Lake County, a body corporate and politic of the State of Utah, hereafter referred to as COUNTY.

1. The County is constructing a storm drain pipeline in 4800 South Street, with a part of said pipeline being located within the Cottonwood Mall.
2. The culinary water supplied to said MALL is presently supplied by the COMPANY. Said water supply is channeled through a regulating station which is located in 4800 South Street.
3. The installation of said storm drain pipeline will require that said regulating station be moved onto private property, owned by the MALL.
4. The parties hereto agree that the COUNTY may move said regulating station out of 4800 South Street and may be moved onto property owned by the MALL.
5. The MALL hereby grants to COUNTY an easement over and through the real property hereafter described for the purpose of removing and installing said regulating station and further grants to COMPANY an easement over the through said property for the purposes of maintaining said regulating station and any pipelines connected thereto.
6. The real property referred to above is more particularly described as follows:

Beginning at a point on the South line of 4800 South Street 1937.86 feet East and 706.75 feet South from the N $\frac{1}{4}$ Corner of Section 9 T2S R1E SLB&M which point of

beginning is S 89°48'E 726.4 feet and S 0°12'W33 feet from a County Monument at the intersection of Highland Drive and 4800 South Street; running thence S0°12'W57 feet thence S89°48'E 27 feet thence N 0°12'E 57 feet; thence N89° 48'W 27 feet to the point of beginning.
