4176709 GRANT OF EASEMENT AND AGREEMENT

4500 SOUTH ASSOCIATES, a Utah limited partnership, of Salt Lake County, Utah ("Grantor"), for and in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, hereby grants and conveys to the SALT LAKE COUNTY WATER CONSERVANCY DISTRICT, a political subdivision of the State of Utah ("Grantee"), and its successors and assigns, a non-exclusive perpetual easement, consisting of the right of ingress and egress for operation, maintenance, repair and replacement of Grantee's culinary water well and related facilities situated on property owned by Grantee, said easement to run over, across and through the land of Grantor along a route more particularly described as follows:

BEGINNING on the south right-of-way line of 4500 South Street at a point which is N 89°50'30" E 458.71 feet along the monument line and South 33.00 feet from a Salt Lake County monument in 4500 South Street; said monument is N 89°50'30" E 1521.879 feet from the Salt Lake County monument in the intersection of 4500 South Street and State Street, (Note: the point of beginning is also described as being 292.20 feet South and 176.18 feet East of the center of Section 6, Township 2 South, Range 1 East, Salt Lake Base and Meridian); and running thence South 65.00 feet; thence East 88.20 feet; thence South 11.76 feet; thence South 32°43' West 15.74 feet; thence West 191.69 feet; thence North 89.67 feet; thence North 89°50'30" East 112.00 feet, to the point of BEGINNING.

Grantor represents and warrants that it is the sole fee title owner of the land burdened by this easement as hereinabove described, and that it has full right and authority to grant said easement.

This easement is granted subject to and in accordance with the following covenants of the parties:

- 1. Grantor may relocate the easement hereby granted to a different location designated by Grantor, but only if such new location does not unreasonably interfere with Grantee's rights of access, ingress and egress pursuant to the easement.
- Grantee shall cooperate with Grantor in the relocation of the easement.
- 3. Any reasonable cost associated with relocating Grantee's route of ingress and egress to its property, in connection with the relocation of the easement as herein provided, shall be borne solely by Grantor.

A new and separate Grant of Easement document shall be prepared and duly executed by Grantor and Grantee at such time as the easement is relocated as herein provided, which such document shall, upon its recordation, replace and supercede this Grant of Easement.
