A perpetual easement over, under, across and through the land of Grantor for the purpose of a ground water well protection zone in accordance with Section 6.3.4. of the Public Drinking Water Regulations of the Utah State Department of Health, now in force or as may be amended from time to time, whereby Grantor and its successors-in-interest shall be prohibited from locating or permitting the location of concentrated sources of pollution, including, without limitation, septic tanks, and drainfield systems, ordinary sewer lines, garbage dumps, pit privies, corrals, feed lots or other such sources of contamination, within said protection zone easement; said easement to be located in Salt Lake County, State of Utah, at a point more particularly described as follows:

The area lying within Grantor's property and within a radius of 100.0 feet from the following described radius point:

A point which is south 45.00 feet from the south right-of-way line of 4500 South Street, which point is N83°50'30"E 483.71 feet along the monument line and South 78.00 feet from a Salt Lake County monument in 4500 South Street; said monument is N89°50'30"E 1521.879 feet trom the Salt Lake County monument in the intersection of 4500 South Street and State Street, (Note: the radius point is also described as being 337.20 feet South and 201.18 feet East of the center of Section 6, Township 2 South, Range 1 East, Salt Lake Base and Meridian).
