AMENDMENT TO DECLARATION OF PROTECTIVE COVENANTS
AND RESTRICTIONS FOR JORDAN VALLEY SUBDIVISION

KNOW ALL MEN BY THESE PRESENTS:

ration, FLOYD E. GRAHAM and IDELLA W. GRAHAM, his wife, PAZ FRANK
GALLEGOS and EMILY GALLEGOS, his wife, ROBERT PALMER
and ADELL R. PALMER, his wife, and CHARLES BURGESS and
Joyce BURGESS, his wife, the owners of the following described
real property situated in Salt Lake County, State of Utah, to-wit:

All of Jordan Valley Subdivision No. 1, according to the official
plat thereof recorded in the office of the Salt Lake County Re-
corder.

do hereby declare that the Declaration of Protective Covenants and Restrictions
of Jordan Valley Subdivision dated the 19th day of May, 1960, and recorded in
the office of the Salt Lake County Recorder's office on the 5th day of July, 1960
in Book 1723, Page 170, are amended as follows:

1. Buildings and structures on said Subdivision may be constructed of
split pumice stone in addition to brick, stone, or lumber materials or combina-
tions thereof as set forth in paragraph 12 of said Restrictive Covenants.
2. Lots 1, 2, 15, and 16 shall also be subject to the Restrictive Cove-
nants on said Subdivision as amended herein.
3. That the Restrictive Covenants heretofore referred to and the amend-
ments hereto shall remain in full force and effect.

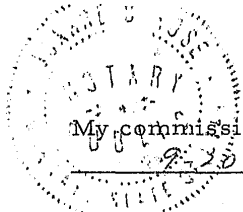

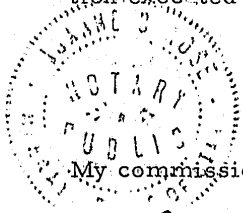
