The final account and report of Hyrum Lemmon and Ezra L. Tanner, the administrators of the estate of William S. Tanner, Deceased, together with a petition for distribution and partition of the residue of said estate, coming on regularly to be heard the 17th day of February A.D. 1912, and proof having been made to the satisfaction of the court that the clerk of this court had given notice of the settlement of said account and report, and the hearing of said petition in the manner and for the time heretofore ordered and directed by the court, and no objections being filed thereto, and it appearing that said account and report is correct in every particular, it is hereby ordered, adjudged and decreed that the said final account and report of the said administrators be, and the same is hereby allowed, approved and settled.

And it further appearing to the court that all claims against said estate are fully paid, including the inheritance tax and all other taxes due from said estate, and that said estate is now in condition to be closed in accordance with law.

That said deceased died intestate and his only heirs at law are his widow, Susan Tanner, Fred Tanner, Leone S. Tanner, Emery Tanner, Ezra L. Tanner, Mabel Tanner, Stewart, Emma L. Tanner, Harold K. Tanner, Kenneth J. Tanner, Olive A. Tanner, sons and daughters of deceased and Vera Tanner, Frank Tanner, Mariam Tanner, Walter Tanner, Willard Tanner, Arthur Tanner, Selma Tanner and Alma Tanner, grandsons and granddaughters of deceased.

That Kenneth J. Tanner and Olive A. Tanner are minors, and that Emma E. Tanner is the duly acting, qualified guardian of the property and estates of said Kenneth J. Tanner and Olive A. Tanner.

That Vera Tanner, Frank Tanner, Mariam Tanner, Walter Tanner, Willard Tanner, Arthur Tanner, Selma Tanner and Alma Tanner are minors, and that Jesse S. Taylor is the duly appointed, qualified and acting guardian of the estate of the said Vera Tanner, Frank Tanner, Mariam Tanner, Walter Tanner, Willard Tanner, Arthur Tanner, Selma Tanner and Alma Tanner.

That on the 18th day of August 1910, by a good and sufficient deed of conveyance, the said widow, Susan Tanner, sold and conveyed and transferred all her right, title, and interest in and to all of the property of the estate of said William S. Tanner, deceased, of every name and nature, to the other heirs of William S. Tanner, deceased, to be distributed among said heirs as would be according to law had not the said Susan Tanner survived the said William S. Tanner, deceased, and that now the said heirs hereinbefore mentioned, are the sole parties interested in the residue of the said estate.

That on the 29th day of January 1912, the said heirs at law of William S. Tanner, deceased, made and entered into an agreement in writing, which said agreement has been duly filed herein, whereby the residue of the estate of William S. Tanner, deceased, should be distributed and partitioned among said heirs as hereinafter set forth, and that said agreement so made and entered into was duly authorized and ordered by this court to be made and was made in behalf of said minor heirs hereinbefore named, by their duly appointed, qualified and acting guardians aforesaid, in accordance with law.

That the residue of the estate of said deceased is the property real and personal hereinafter set forth and described and distributed and partitioned to the heirs at law of said William S. Tanner, deceased, and that in accordance with said agreement of heirs aforesaid, and in accordance with law, it is now ordered, adjudged and decreed that the residue of said estate be
